Experience Criteria:

The bidder should meet the following minimum qualifying Criteria:



- (ii) In case dealer is participating in a tender on behalf of one manufacturer he is not allowed to participate/quote on behalf of another manufacturer i this tender or in a parallel tender for the same item. All such bids wit same make/manufacturer will be rejected.
- (iii) A valid ISO certification of manufacturer for manufacturing the main component of AWS *i.e. Data Logger* should be submitted with the bid.

Financial Criteria:

a. **Turnover**: The average annual financial Turnover of 'The bidder during the last three years, ending on 31.03.2021 should be at least ₹ lakh as per the Annual Report (Audited Balance Sheet and Profit & Los account) of the relevant period, duly authenticated by a Chartere Accountant/Cost Accountant in India.

- b. **Working Capital**: The working capital (current assets minus curren liabilities) shall be equal to at least 3 times the monthly cash flow requirement i.e. Estimated cost of Work*3/Supply period = 28.13 Lakh.

- 1. The Technical Specifications mentioned in the document are minimun technical Specifications to be met by Manufacturer/ Suppliers an higher/better specifications are acceptable.
- 2. Prices shall be Firm and final. The quoted prices shall be inclusive of a taxes, levies, transportation, loading/unloading charges etc. for supply c equipment & materials required for the above supply, installation, testing commissioning of AWS with telemetry complete in all respect at Project Sit at Drabshalla, Kishtwar, J&K as per Technical Specifications (TS) and Specia Conditions of Contract (SCC).
- 3. **Engineer-In-Charge**: General Manager (Civil), Power House or hi authorised representative.

4. Payment Terms:

- a. 80% payment against supply item (BoQ Item-1) shall be released afte supply, verification and inspection of equipment/material at Ratle H Project, District Kishtwar, UT of J&K and upon production of all original documents/invoice/challan.
- b. Balance 20% payment against supply item (BoQ Item-1) and 100% payment against BoQ Item-2 shall be released after Installation

Testing & Commissioning of AWS with Telemetry.

- c. Payment against BoQ Item-3 & 4 shall be released on yearly basi within one month of the start of the period of Comprehensive onsit warranty / comprehensive AMC.
- 5. **Delivery Schedule**: The entire scope of work as defined in Technica Specifications Cl.No. 1 shall be completed within **45 days** from the date c issue of Supply Order.
- 6. Supplier shall submit Performance bank guarantee (in format provided of GeM) for amount equal to three percent (3%) of the Award Value valid for 2 months beyond the date of completion of all contractual obligations, consubmit Demand Draft of same value in favour of Ratle Hydroelectric Powe Corporation Limited payable at Kishtwar, within a period of 14 days from the date of issue of Supply Order.
- 7. **Inspection**: Inspection of material shall be carried out by authorise representatives of Ratle HEP at the premises of the Firm before the dispate of material and/or at the time of delivery of material at Project Store.

8. Warranty:

- a. Onsite Comprehensive Warranty for Two years followed by Comprehensive Annual maintenance contract (CAMC) for next Five years for the Product starting from the date of commissioning shall be provided by bidder/manufacturer/supplier. Its scope shall also cove one regular inspection/ preventive maintenance visit by Technica team of supplier/manufacturer and supply of any damage part/spares/tools etc. required for repair/maintenance of equipmer with no additional cost payable by owner. The Onsite Comprehensive Warranty shall cover the manufacturing defects.
- b. Response time to attend/investigate the complaint during warrant shall be less than 48 hours. Time duration for repairing/replacement c damaged parts shall be limited to 12-15 days from date of registerin Complaint.

- 11. Bidder/Supplier shall provide Calibration Certificate for the Data Logger a required from national/international Accredited Labs/ Authorised Agencies c NABL/ILAC/WMO/IMD at the time of Supply/Installation.
- 12. The bidder/supplier/manfacturer shall ensure support for AWS datalogger GPRS/VSAT modem, sensors and spares availability for 10 years from date c purchase.
- 13. The licence for remote monitoring software shall be subscription based an the quoted cost shall include the cost of 2-year subscription for the licence.

- 14. The firm shall provide presentation and demonstration of the complete AW system including sensors, Datalogger, Communication equipmer (GPRS/VSAT).
- Training 15. Onsite shall be provided by representatives Manufacturer/Supplier for running, troubleshooting, repair, maintenance of the equipment. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

7. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buye
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

12. Forms of EMD and PBG

Bidders can also submit the EMD with Banker's Cheque in favour of RATLE HYDROELECTRIC POWER CORPORATION LIMITED payable at KISHTWAR.

Bidder has to upload scanned copy / proof of the BC along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

13. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of RATLE HYDROELECTRIC POWER CORPORATION LIMITED payable at KISHTWAR. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buywithin 15 days of award of contract.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void.
